harassment u s equal employment opportunity commission us eeoc Oct 02 2020 the employer is automatically liable for harassment by a supervisor that results in a negative employment action such as termination failure to promote or hire and loss of wages if the supervisor s harassment results in a hostile work environment the employer can avoid liability only if it can prove that it reasonably tried to prevent
